6.1 Usage

To restore to liquid egg, use about 1 kg of whole egg powder and 3 kg of water. If applicable, mix the powder with other dry ingredients before adding the water.
Recommendation is to use the solution within 4 hours.
A standard egg weighs 50 grams (without the shell). This means that you need 12.5 grams of egg powder and 37.5 grams of water to replace 1 egg.
